### **LEGISLATIVE**

Well the election has come and gone and the American people have spoken so now it is time to go to work. The House and Senate returned to work and immediately began working on the National Defense Authorization Act for 2017. This bill is especially important to us because it funds all of our retiree and healthcare benefits. The good news is that AFSA never stopped working on this legislation and, during the campaign, did the quiet but essential work behind the scenes to protect our hard-earned benefits. So, what does this bill include?

The House adopted the conference report on the bill that would authorize \$611.2 billion for defense programs in fiscal 2017, including \$59.5 billion for overseas operations in Afghanistan, Iraq and Syria. It would authorize \$222.4 billion for operations and maintenance; \$139.6 billion for military personnel; \$7.9 billion for military

construction and family housing; \$10 billion for ballistic-missile defense; and \$33.4 billion for defense healthcare programs, including \$334 million from the overseas operations account. It would prohibit the use of funds for a new round of base closures. The bill would authorize a 2.1 percent pay raise for military personnel. It would elevate U.S. Cyber Command to an independent major command within the Defense Department. It would prohibit detainees at Guantanamo Bay, Cuba, from being transferred to U.S. soil, and would prohibit the closing of the main base and detention facility at Guantanamo. It would also extend, through fiscal 2017, the authority for several bonus and special payments for military members. The bill still must be passed by the Senate and signed by the President but, at this time, no major changes are expected.

AFSA, through our legislative team on Capitol Hill, managed to hold off any changes to TRICARE for Life for current recipients and also prevented most of the catastrophic changes to the TRICARE system that the current administration had sought. While "working age" retirees may see a modest annual enrollment fee, the higher premiums, higher copays for medications, and loss of TRICARE Prime feared by many are off the table.

Lastly, it looks like our Commissary and BX systems will remain unchanged in the short term. Congress would still like to see the DoD make the system more efficient, but they are honestly not sure the best way to go so, for now, these benefits are safe and unchanged. Let's hope the Senate doesn't do anything too drastic so we can lock these legislative victories in and begin the fight for next year's battles.

Keep communicating with your elected officials and remind them that now it is time to go to work. On January 20<sup>th</sup>, we will welcome a new President and a new administration with a promise to take care of our nation's veterans. Now it is up to us to hold them accountable and to do our part in fighting for our hard-earned benefits. Are you with me?

With Valentine's Day approaching, here is a melt-in-your-mouth cookie recipe to make for your loved ones.

### **Cherry Cheesecake Cookies**

1/4 cup butter, softened
1 (8 oz) pkg cream cheese, softened
1 egg
1/4 tsp vanilla extract
1 pkg white cake mix
3/4 cup maraschino cherries, chopped

- Chop cherries and place on a paper towel to absorb excess juice.
- Cream together butter and cheese with electric mixer until smooth.
- Add in egg and vanilla.
- Add cake mix 1/3 at a time. If mixture is too heavy for mixer, use hands to knead in the cake mix.
- Add cherries to batter.
- Wrap in plastic wrap and chill for 30 minutes.
- Drop batter in lumps (mixture may be a bit sticky) 2" apart on lightly greased cookie sheet.
- Bake at 375 degrees for 7-9 minutes. Cool slightly before removing from baking sheet.
